Absentee Meeting/Pre-Election Day Meeting March 4, 2024

5:00 pm

The Bertie County Board of Elections held an Absentee Meeting. The meeting took place at 5:00 pm at 210 W. Watson Street, Windsor, NC.

The meeting was called to order by Chairman Wm. Michael Freeman. Mr. Lee gave the Invocation.

Business

Review of received Absentee Ballots

The first order of Business was the review of received Absentee Ballots.
